All teams must be ready and able to play throughout the entire tournament, including the full duration of Friday. No team or player should book travel to leave Palm Beach County until Saturday 7 May 2022.

Team Social Event

An indoor mass gathering is not planned due to Covid-19. Venues will provide a Cocktail hour for players at each specific venue (except W55 who will go to Woodfield Country Club) on the following days:

Tuesday 3 May - Woodfield Country Club (+ W55)

This will take place at approximated 6pm (subject to completion of matches). Transport will not leave until after this has taken place (approximately 7pm)

Medal Ceremonies

Medal ceremonies will take place at each venue with medals awarded to all teams finishing from 1st to 4th place in each event. All medal teams must attend the medal ceremony at their venue on the final day, which will begin promptly after the final medal match at each venue has concluded.

Boca Grove Country Club will only be used if other additional courts are required. This venue may be available for practice for teams that are not scheduled to play on the Sunday 1 May or Monday 2 May – Further details will be provided soon.

Whilst the intention will be for teams to play matches at one venue throughout the week, some teams may be required to play at a different venue on some days depending on final entry numbers, draws and weather. Official transport will be provided from all official hotels to all venues.

Singles Scoring Format: Best of 3 tie-break sets in all singles matches

Doubles Scoring Format: Best of 3 tie-break sets in all round robin matches, main draw Quarter Finals, Semi Finals, Final and 3rd/4th playoff. Doubles will be played as 2 tie-break sets and 10-point match tie-break in non-medal matches, and ties where the score is 2-0 after singles. Doubles played Wednesday onwards that do not impact medal positions shall be played as 2 tie-break sets and 10-point match tie break.

Player Accreditation

Team Captains must collect player accreditation for their team members at the Captains Meeting on Saturday 30 April. Players must wear their accreditation when they're on site (except for during matches).

Player Welcome Gift

All team players will receive a player welcome gift – this will be given to teams at their first match. This will be Sunday 1 May or Monday 2 May depending on the format of play.

Hotel Information

Official tournament hotels can be booked through <u>Event Connect</u>. A special rate has been agreed at the following hotels In Boca Raton which are available to book through Event Connect. Any player booking direct with the hotels or through any other website will not be eligible for the tournament rate.

Prices are quoted <u>per room</u> and will remain as published whether there are 1, 2 or 3 persons staying in a room. Breakfast is included in the room rate. Room bookings at each hotel are available on a first come, first served basis.

Cancellations can be made until **Monday 18 April 2022** and will be refunded, except for service fees which are non-refundable. Cancellations following this date will be charged. Please note, tournament participants are responsible for ensuring responsibility for all cancellation deadlines, which are managed by the hotels, and should rely on direct enquiries with Event Connect to manage this.

Practice Courts

All venues **EXCEPT BOCA WEST** for the Team Event will host practice on Friday 29 April (Teams playing at Boca west may choose to practice at another venue).

All venues will host practice on Saturday 30 April.

It may be possible to practice at the venues on Thursday 28 April, but transport and balls will not be provided on these days.

Transport will be available from official tournament hotels to venues from Friday 29 April. A transport schedule will be available prior to the tournament.

Practice Courts: Teams will be permitted to book a 90-minute practice slot on Friday 29 April. Teams will be permitted to book a 75-minute practice time on Saturday 30 April.

Practice Court Bookings: Practice courts for Friday 29 April and Saturday 30 April 30 may be booked <u>in advance</u> by emailing <u>tennis1gal@gmail.com</u>. Practice court bookings will open on Monday 11 April 2022. Please clearly state the name of the team and requested time. Priority will be given to teams that book practice courts at the venue that they will be playing at.

Emails received before 11 April will not be prioritized. Once on-site, teams may book practice courts (subject to availability) at the club Pro Shop at the site where they are playing their matches.

Airport Travel and Transport Details

There are three recommended airports' for players to consider:

- 1. Miami International Airport (MIA) 100km from Boca Raton
- 2. Fort Lauderdale International Airport (FLL) 35km from Boca Raton
- 3. Palm Beach International (PBI) 35km from Boca Raton



<u>Due to the ongoing disruption of Covid-19 on travel restrictions, participants are strongly advised to consider travel insurance which incorporates flight cancellations and/or refundable ticket options when booking flights.</u>

Airport Transportation

Complimentary airport transportation is not provided from the airport(s) to the hotels and/or tennis venues. Players are recommended to take one of the following affordable options which include the Tri-Rail (train) available from Fort Lauderdale Airport and Miami Airport. This stops at Boca Raton Tri-Rail station.

Tri-Rail

A one-way trip from Miami International Airport to Boca Raton station is \$6.25 per person (as of January 2022). Full details including fares and schedules can be found at https://www.tri-rail.com/

Bus Transportation

Transportation from Miami Airport or Palm Beach International Airport may also be scheduled by contacting Bus One. Bookings must be made at least 48 hours in advance of your arrival and is a recommended option for larger groups. Please note that this is not part of the official transportation for the World Championships and is the Team/Players are responsible for contacting the company directly. Last minutes changes to confirmed bookings (such as departure dates/times/number of persons) can be made by text or calling 561-543-7771

Uber of Lyft Transfers

Approximately \$35 from Fort Lauderdale Airport to official hotels located in Boca Raton. Uber or Lyft are also recommended to transfer from Boca Raton Tri-Rail station to hotel in Boca Raton (approximately \$8-10 fare). Transport to Palm Beach Gardens for Individual Event

For those competing in the Team Event in Boca Raton, Buses will depart from the Official Hotels in Boca Raton at 9.00am on Saturday 7 May for players playing in the World Individual Championships being played in Palm Beach Gardens (45 minutes from Boca Raton). Players who competed in the Team Event who are scheduled to play on Saturday 7 May will be given a not before start time of 13.00pm in Palm Beach Gardens.

Cost of bus is \$20 per person which can be booked at the Tournament Desk of each Team Cup venue. Spaces on the bus must be reserved by 15.00pm on Tuesday 3 May 2022.

Sports Medicine Physiotherapists

Athletic Trainers (Physiotherapists) will be available at each site 30 mins prior to the start of the first team practice until the end of play. There is no charge for basic wrappings and on court assessments but if a trainer or a physician treats a player for a specific injury, charges for required treatments must be paid by the player.
